On 05/13/2026 I was assigned to Uniformed Patrol for the Potter County Sheriff's Office. I was assigned to East Beat in Unit 6331. At approximately 1351 hours I checked out with a suspicious vehicle on SH 136 near Rancho Rd. there is audio and visual from my body worn camera for this incident.

I checked out with the vehicle, identified as a 2000 Chevy Silverado bearing TX tag# SWL5202. The truck was parked on the southbound side on the shoulder. I found the passenger door unsecured, and inside the vehicle was several garbage bags full of clothing, a purse, thermos, and assorted tools and other miscellaneous items. The radio was removed from the dash, and both doors were in a state of disrepair. I attempted to lock the passenger door, but was unable. The vehicle showed a registered owner of SAENZ, ELOY with an address of 910 East Ripley St Brownfield, TX 79316. Inside the purse I found a Venmo card with the name LIBERTY DAWSON on the back. I was unable to locate contact information for either subject, and had dispatch T-Miller to impound the vehicle. I completed the vehicle inventory sheet, and later turned it into the CID box. T-Miler arrived and took possession of the vehicle,

and I returned to service. Due to my department issued camera's batteries being dead I used my body worn camera to document the vehicle. EOR
